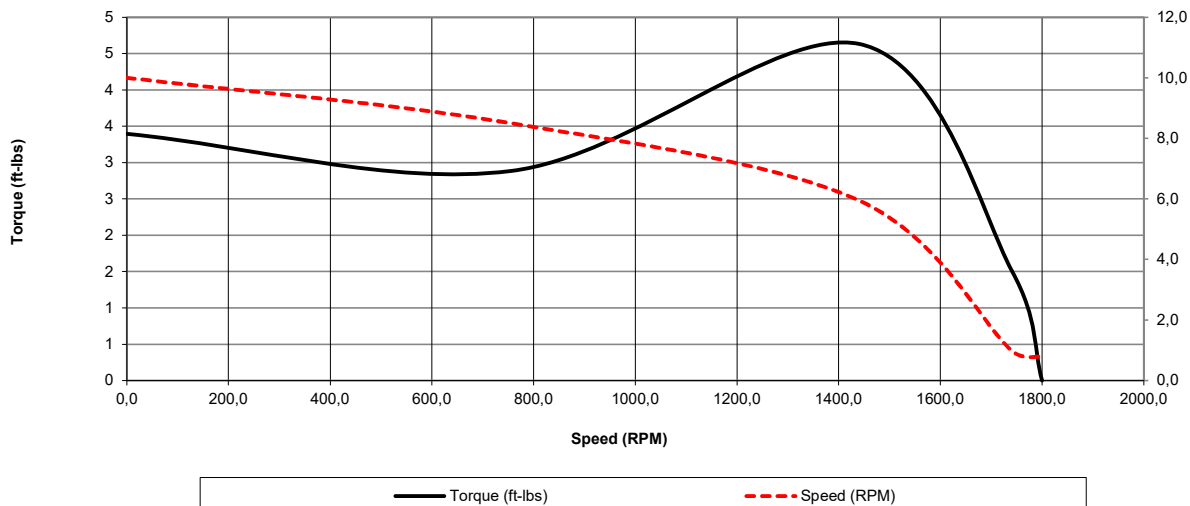

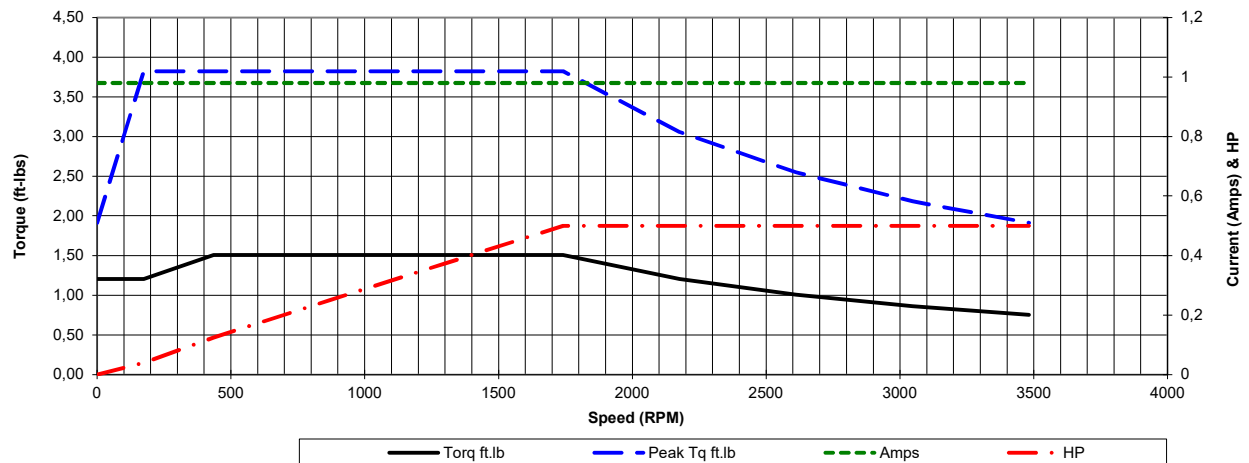

Motor Torque Capability vs RPM





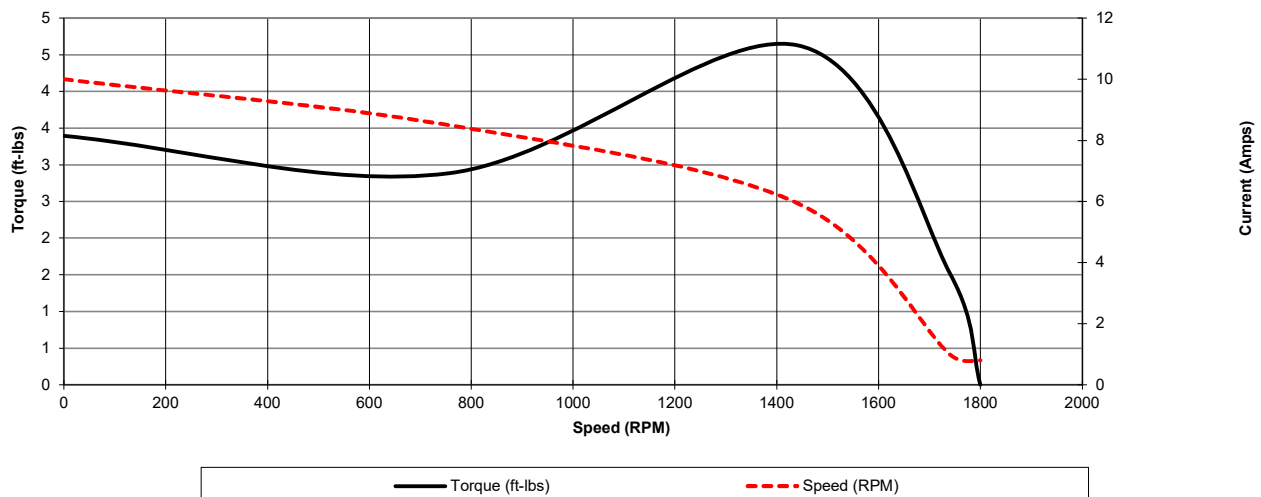
